### Definition: Indigent Care

Provide necessary medical care and treatment to all patients regardless of their ability to pay for services rendered. The Indigent/Charity Care Policy (Financial Assistance Program) establishes the means for ensuring that qualified patients of Wills Memorial Hospital who are deemed eligible under specified guidelines will receive full or partial financial assistance (free or reduced costs) for debt associated with medical services provided by Wills Memorial Hospital.

## Community Benefit Glossary

Term	Definition
Indigent (Charity) Care	Financial assistance provided to patients who meet the Health System's eligibility criteria and are unable to pay for medical services. Charity care provided free or at a reduced cost to ensure access to essential health services.
Bad Debts (Implicit Price Concessions)	Amounts for services provided but ultimately not collected, typically because patients were unable or unwilling to pay and did not qualify for charity care. These uncollected amounts are reductions in expected payment rather than charity care.
Uncompensated Care	The combined cost of charity care and bad debt, representing the portion of care for which the Health System receives no payment. Reflects the Health System's role in ensuring access to essential care for all patients.
Health Professions Education	Programs that train future health professionals—such as physicians, nurses, pharmacists, therapists, and allied health students. These programs expand the local healthcare workforce and improve access to quality care.
Community-Based Health Education Sessions	Health promotion programs offered in community settings—schools, churches, civic centers, workplaces, or public events—to help residents improve health knowledge and prevent disease. Provided at no cost to participants.
Community-Based Clinical Health Services	Free or subsidized clinical services provided outside the hospital, such as screenings, immunization events, mobile health clinics, and chronic disease management programs. Services meet identified community health needs and remove barriers to care.
Cash Contributions	Direct financial support the Health System provides to nonprofit organizations, community partners, and public agencies to address community health needs—such as support for clinics, health initiatives, social services, and local health improvement efforts.
In-Kind Contributions	Non-financial support donated by the Health System, such as staff time, medical supplies, facility space, or equipment, to assist community organizations and community health programs.
Community Health Care News (Health-Related Outreach)	Health information shared with the public—such as newsletters, online education, health alerts, classes, and outreach materials—that promote wellness, prevent disease, and support informed decision-making.
